FREQUENTLY ASKED QUESTIONS

What specifically what does my contribution support?

Your contribution can be earmarked for a specific area of the FMAF (see next question) or be placed in the general fund. General funds allow for FMAF to allocate your donation to areas where the best opportunities exist.

How do I help decide what my donation is going to?

Earmark your donation to one of the following categories: Program Promotion, or Scholarships, or for the General Fund.

Is this donation tax deductible?

Yes, in many countries your donations are tax deductible. Please contact your local government agency to find out if this applies.

What if I financially give year after year while others choose not to?

Your gift to the FMAF is a personal decision that reflects your choice to support the growth of the program of which you are a member. While there are tangible benefits to giving, the true benefit is that you are providing a better future for The Master.

When is the deadline to donate so that I receive credit for a particular year?

For gifts to be applied to a particular tax year they must be post-marked by December 31st for the year in which you would like them counted.

Will my Employer match gifts to this charitable foundation?

Check with your benefits administrator to see if they will match or partially match gifts to the Foundation. This practice varies from country to country.
